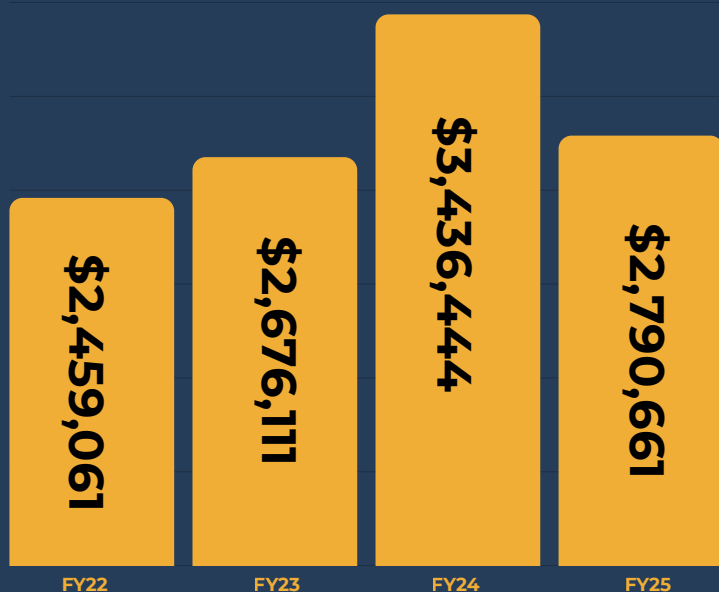

The New Mexico Crime Victims Reparation Commission administers its federal and state funds to support survivors' services through a comprehensive statewide plan that outlines funding priorities and strategies to enhance responses to victims of domestic violence, sexual assault, stalking, homicide victims, and victims of crime throughout New Mexico. This comprehensive plan was developed in collaboration with all stakeholders and providers of victim services throughout New Mexico to ensure it addresses the needs of crime victims in the state.

### Victims of Crime Act (VOCA) Assistance Grant Funds **\$5,093,081.00**

The Victim of Crime Act Assistance (VOCA) grant serves a vital mission: to extend compassionate support and direct services to crime victims throughout the state. These funds are dedicated to addressing the emotional and physical needs of victims, empowering them to rebuild their lives, navigate the complexities of the criminal justice system, and ensure their safety and well-being. This invaluable funding is available to state agencies, local governments, non-profit organizations, Native American tribal governments, and hospitals that provide essential services such as crisis counseling and support groups. In New Mexico, these resources have made a profound impact, **supported 76 projects and uplifted the lives of 23,016 victims, survivors, and clients**. Together, we can create a safer, more supportive environment for those affected by crime.

### Sexual Assault Service Program (SASP) Grant Funds **\$817,188.00**

The Sexual Assault Service Program (SASP) is committed to advancing the establishment of locally based and supported nonprofit programs that serve survivors of sexual assault across the state. Our mission is to ensure the highest standards of service quality for these survivors. This funding is crucial for providing intervention, advocacy, accompaniment, and comprehensive support services for adult, youth, and child victims of sexual assault, as well as for their family members and others who are indirectly impacted by these crimes. In New Mexico, we are proud to have funded 16 impactful projects that are making a difference in the lives of survivors.

### STOP Violence Against Women Act (VAWA) Grant Funds **\$1,289,425.00**

The STOP Violence Against Women Act (VAWA) funds are dedicated to empowering communities in their mission to create and strengthen effective law enforcement and prosecution strategies that combat violent crimes against women. Moreover, these funds play a crucial role in enhancing vital support services for victims of domestic violence, sexual assault, stalking, and dating violence. In New Mexico alone, this initiative has fueled 31 transformative projects, providing direct assistance to an impressive 5,291 victims, survivors, and clients, demonstrating a profound commitment to making a difference in the lives of those affected.

### State Funding for Victim Service Providers **\$18,667,768.00**

The state funds play an essential role in empowering individuals affected by crime. They provide vital support for law enforcement victim advocates, ensuring that those facing challenges such as human trafficking, missing persons cases, and issues related to victim rights receive the necessary assistance. Additionally, these funds deliver emergency support to crime victims, guardianship services, and critical civil legal aid. These resources are also key in strengthening the infrastructure for sexual assault support and enhancing the effectiveness of the New Mexico Intimate Partner Death Review Team. With the State Services Funding support 70 impactful projects, we have successfully reached and supported 17,066 victims, survivors, and clients throughout New Mexico.
